

ARTICLES OF INCORPORATION

OF

OSPREY CONSTRUCTION GROUP, INC.

ARTICLE I

The name of the corporation is OSPREY CONSTRUCTION GROUP, INC.

ARTICLE II

The effective date of this corporation shall be February 1, 2002. The period of its duration is perpetual.
