The undersigned Subscriber to these Articles of Incorporation, a natural person competent to contract, hereby form a corporation under the laws of the state of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in all lawful activities or business permitted under the laws of the United States and of the State of Florida, or any other state

The activities may include but not be limited to preschool activities, child care services and any other activities related to child care industry.

ARTICLE III. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation in the State of Florida shall be located at 332 Palm Way Lane, Orlando, FL 32828. 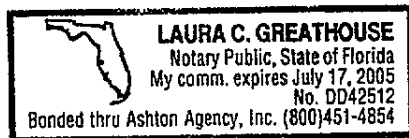
