The undersigned incorporator hereby makes, subscribes to, acknowledges, and causes to be filed these Articles of Incorporation (hereinafter these "Articles") for the purpose of incorporating a corporation for profit under the Florida General Corporation Act, Chapter 607, Florida Statutes.

**ARTICLE I  
(Name of Corporation)**

The name of the corporation is **Bloomin' Acres Landscape, Inc.** (the "Corporation").

**ARTICLE II  
(Corporate Existence)**

The time and date on which corporate existence of this Corporation shall begin is 12:01 A.M. (local time) on February 4, 2002, and the Corporation shall have continuous and perpetual existence thereafter.

**ARTICLE III  
(General Purpose of Corporation)**

The general purposes for which the Corporation is initially organized are as follows:

To operate a nursery and landscape business and to transact any other lawful business for which Corporations may be incorporated under Chapter 607, Florida Statutes.

**(Board of Directors of Corporation)**


