The undersigned subscriber to these articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I – NAME

The Name of the corporation shall be: Anchor WOOD AND MORE, INC. The principal Place of business will be 14785 144th Street, Live Oak, FL 32060.

ARTICLE II – DURATION

This corporation shall have perpetual existence.

ARTICLE III – PURPOSE
