ARTICLES OF INCORPORATION OF N&N CONSTRUCTION, of North Florida, INC.

The undersigned, for the purpose of forming a corporation under the Florida business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I NAME AND ADDRESS
