ARTICLE I - Name

The name of this corporation is EBT Diagnostics, Inc.

ARTICLE II - Duration

This corporation shall exist in perpetuity.

ARTICLE III - Purpose

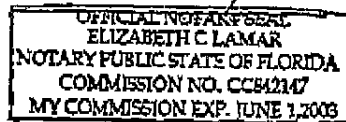
