**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

1. **NAME.** The name of the Corporation is: Yard Signs, Inc.
2. **PRINCIPAL OFFICE.** The address of the principal office of the corporation is as follows:

3. **PURPOSE.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. **CAPITAL STOCK.** The corporation is authorized to issue ONE HUNDRED MILLION (100,000,000) shares of common stock, all of one class, at **NO** Par Value.

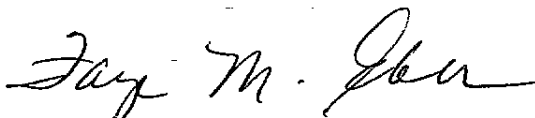
