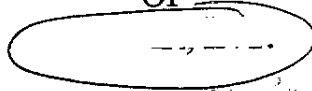

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

ROMARTY, INC.

The name of the Corporation shall be  and the address of this Corporation shall be 3029 S. W. Captiva Court, Palm City, FL 34990.

ARTICLE II

DURATION

This Corporation shall have perpetual existence unless dissolved by administrative action.

ARTICLE III

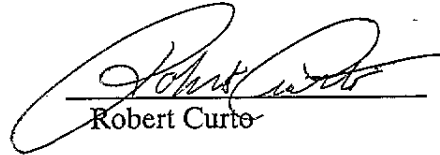
