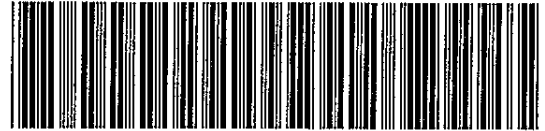

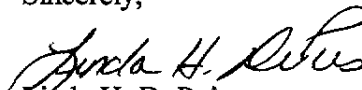

Pursuant to the provisions of Section 607.1006, Florida Statutes, **Edward N. Feldman, M.D., P.A.**, a Florida professional corporation, adopts the following First Articles of Amendment to its Articles of Incorporation:

FIRST: Article I is hereby amended to read as follows:
