ARTICLES OF INCORPORATION
(Professional Corporation)

The undersigned, all of whom are duly licensed to practice medicine, in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

I. NAME

The name of the professional Corporation is SCOTT M. GEBHARDT, D.O., P.A.

II. PURPOSE

The purpose for which the Corporation is organized is to practice the medical profession.

III. ELECTION UNDER PROFESSIONAL
CORPORATION ACT

The Corporation elect to be governed by the provisions of the Florida Professional Service Corporation and Liability Act.
