Article I  
Identification

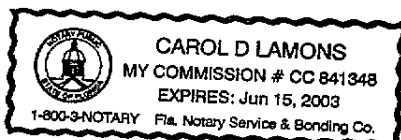

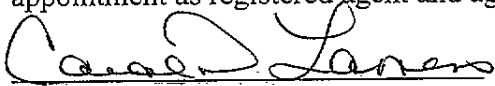

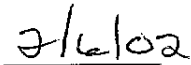
