# ARTICLES OF INCORPORATION

We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

# ARTICLE I

THE NAME of the Corporation shall be:

THE CORPORATION may engage in the activity REALTOR ASSOCIATES, permitted under the laws of the United States of America and of the State of Florida.

#### **ARTICLE III**

THE MAXIMUM number of shares of stock which the Corporation shall have outstanding at any time, shall be **ONE HUNDRED (100)** shares of stock which shall be common stock of a par value of **FIFTY DOLLARS (\$ 50.00)** per share.
