# ARTICLES OF INCORPORATION

ALLAHASSEE, FLORINA We, the undersigned, all being of full age, do hereby associate ourselves together, and do hereby agree for ourselves, our associates and our assigns, to become a corporation for profit under the laws of the State of Florida, of the United States of America, by and under the provisions and statutes of that State providing for the formation, liability, rights, privileges, benefits and obligations conferred and imposed by said law on corporations organized pursuant to the provisions thereof, and hereby make, subscribe and acknowledge and file these Articles of Incorporation as follows:

#### ARTICLE I

#### CORPORATE NAME

#### ARTICLE II

#### PURPOSE

The nature and purpose of the business to be transacted by this corporation shall be: BUY AND SELL PROPERTIES.
