ARTICLE I: NAME

The name of this corporation is Charlene A. Anderson, P.A.

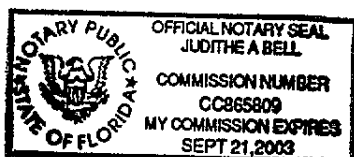
