ARTICLES OF INCORPORATION
OF
KEITH A. MORSE, DMD, P.A.,
A FLORIDA PROFESSIONAL SERVICE CORPORATION

THE UNDERSIGNED, for the purpose of forming a professional corporation in accordance with the FLORIDA PROFESSIONAL SERVICE CORPORATION AND LIMITED LIABILITY COMPANY ACT to practice the profession of or perform the service of Dentistry in the State of Florida, hereby adopts the following articles of incorporation for the corporation:

FIRST: The name of the corporation (the "Corporation") is:

SECOND: The principal office or mailing address of the Corporation is:

THIRD: The aggregate number of shares that the Corporation is authorized to issue is **SEVEN THOUSAND FIVE HUNDRED (7,500)** shares of common stock, the par value of each such share shall be **ONE AND NO/100S DOLLARS (\$1.00)**. Par value shall have no effect on the Corporation's capital structure.

FOURTH: Shares of the Corporation shall be issued or transferred only to persons duly licensed or authorized by law to practice the profession or perform the service of Dentistry in the State of Florida. If any officer, shareholder, agent, or employee of the Corporation becomes legally disqualified to render the professional services for which the Corporation is organized, or accepts employment that places restrictions or limitations on his or her continued rendering of professional services, he or she shall immediately sever all employment with the Corporation and transfer all of his or her shares of the Corporation to an eligible shareholder, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the Corporation on account of professional services.
