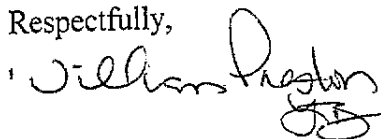

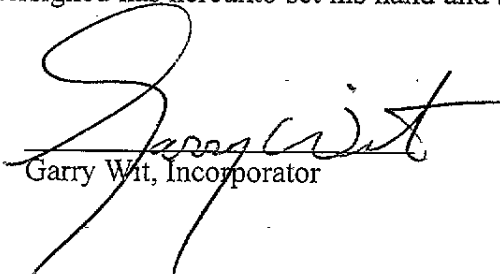

This corporation shall have perpetual duration and succession in its corporate name.

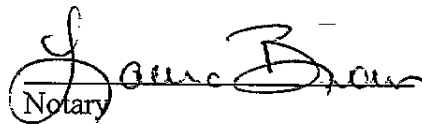

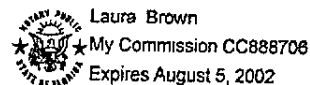

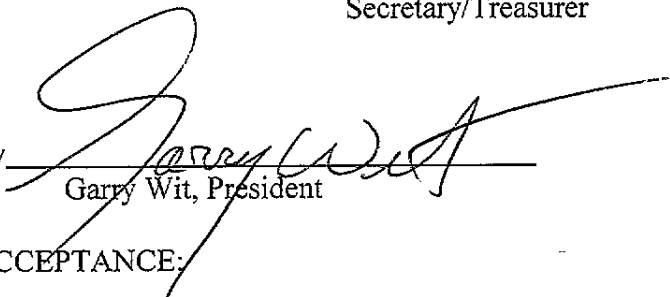
