**ARTICLE VII
LIMITATION OF LIABILITY**

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.

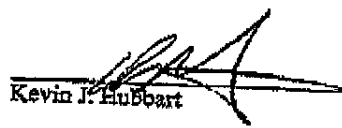

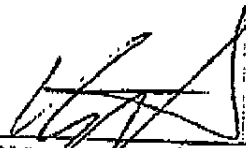
