ARTICLE I - NAME

The name of this corporation shall be:




This corporation shall indemnify any officer or director, or any former officer or director to the full extent permitted by law.






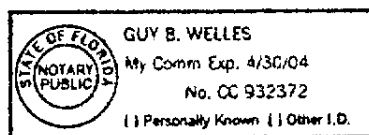
