# Articles of Amendment to Articles of Incorporation of

Pursuant to the Provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:


First: "ARTICLE 1 – Name", of the original Articles of Incorporation provided: "The name of the Corporation is **Gardens of America Group, INC.**"

Second: "ARTICLE 1 – Name" is now amended to read: "The name of the Corporation is **American Gardens Group, Inc.**"

Third: The amendment shall take effect June 10, 2002.
