ARTICLES OF INCORPORATION

Southern Breeze Heating & Cooling, Inc

OPTO STATE OF THE The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1. NAME

The name of the corporation shall be: Southern Breeze Heating & Cooling, Inc

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in the business of air conditioning installation and repair in the state of Florida.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Florida.

ARTICLE III. CAPITAL STOCK
