ARTICLES OF INCORPORATION

OF

STRATEGIC MEASURES, INC.

OZ FEB I M 8: 23 In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

Article I

Name. The name of this corporation is STRATEGIC MEASURES, INC. (hereinafter referred to as the "Corporation").

Article II

Address. The street address of the principal office of the Corporation is 201 N. Macdill Ave., Tampa, FL 33609.

Article III

Duration. The Corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Secretary of State of the State of Florida.

Article IV

Purpose. The Corporation is authorized to transact any lawful business for which corporations may be formed under Chapter 607, Florida Statutes.

Article V
