Name**

The name of the Corporation is **Urra's Iron Works Corporation** hereinafter referred to as the "Corporation."

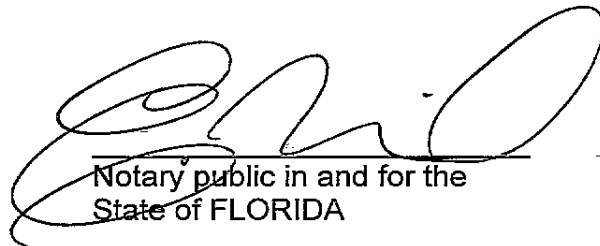
