ARTICLES OF INCORPORATION

OF

I, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

I. NAME

The name of the Corporation shall be Positive Impact, Inc.

II. PURPOSE
