#### ARTICLE I - NAME

The name of this corporation is 3331 CORP., with its principal office and address being located at 2708 N.E. 37th Drive, Fort Lauderdale, 33308.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.
