ARTICLES OF INCORPORATION
OF
MILLER STAFFING SERVICES, INC.

ARTICLE I. - NAME

The name of the corporation is **MILLER STAFFING SERVICES, INC.** The address of the principal office of this corporation shall be 9150 West Lake Ruby Drive, Winter Haven, Florida 33884, and the mailing address shall be the 9150 West Lake Ruby Drive, Winter Haven, Florida 33884.

ARTICLE II. - DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of the State of Florida.

ARTICLE III. - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of \$1.00 par value common stock which shall be designated "common shares".

ARTICLE V. - PREEMPTIVE RIGHTS

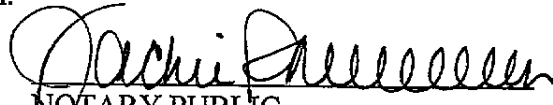
