**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is PAONESSA ONCOLOGY MANAGEMENT COMPANY, and the principal address and principal place of business is 1201 5TH AVENUE NORTH, SUITE 505, ST. PETERSBURG, FLORIDA 33705.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
