ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is VAN PROPERTY MANAGEMENT, INC., and the principal address and principal place of business is 12411 STILLWATER TERRACE DRIVE, TAMPA, FLORIDA 33624.

ARTICLE II - REGISTERED OFFICE AND AGENT
