In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is THE LAUNCH PAD CHILD DEVELOPMENT CENTER, INC.

**ARTICLE II**

The existence of the Corporation shall begin upon the filing of these articles with the Florida Secretary of State.

**ARTICLE III**
