ARTICLE I- NAME

The name of this corporation is:

RADIOLOGY & THERAPY SERVICES, INC.

ARTICLE II- DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers and the filing of the Articles of Incorporation with the Secretary of State.

ARTICLE III- PURPOSE

When payment of the consideration for which shares are to be issued shall have been received by the corporation, such shares shall be deemed to be fully paid and non-accessible.


