

I. NAME

The name of the corporation is CALUSA TITLE, INC.



#### X. AMENDMENTS

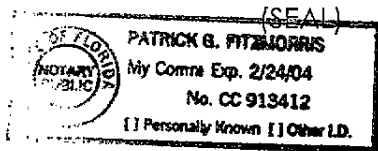
