

I. NAME

The name of the corporation is CALUSA TITLE, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

III. NATURE OF BUSINESS


IX. SUBSCRIBER AND INCORPORATOR



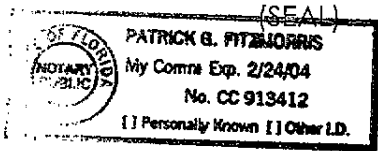


