The undersigned Incorporators of these Articles of Incorporation, being natural persons competent to contract, hereby form a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

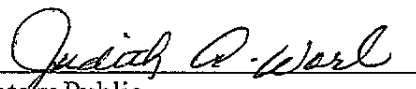

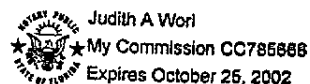
