ARTICLES OF INCORPORATION

OF

MONTANA HOLDINGS, INC.



The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I Name and Address

The name of the Corporation shall be **MONTANA HOLDINGS, INC.**, and its mailing address is 2861 34TH Street South, St. Petersburg, Florida 33711.
