The undersigned as the Incorporator named in the Articles of Incorporation of HOLLOWAY CONTAINERS, INC., a Florida corporation (the "Corporation"), before the issuance of any shares of stock and before the organizational meeting of the initial Board of Directors hereby adopts the following Articles of Amendment:

1. The name of the Corporation is Holloway Containers, Inc.

2. Article V of this Corporation's Articles of Incorporation is hereby amended in its entirety so as to read, after amendment, as follows:

"ARTICLE V.

"CAPITAL STOCK

"This corporation shall be authorized to issue Ten Million (10,000,000) shares of Two/One Thousandths of a Dollar (\$.002) par value stock divided into two classes of stock: Class A Voting Common and Class B Non-Voting Common. Said classes of stock shall be identical in all respects except that shareholders owning Class B Non-Voting Common stock shall have no voting rights of any kind or nature whatsoever. The par value and authorized issue of such classes of stock shall be as follows:

	<u>PAR VALUE</u>	<u>AUTHORIZED ISSUE</u>
Class A Voting Common	\$.002 per share	500,000 shares
Class B Non-Voting Common	\$.002 per share	9,500,000 shares"

3. The foregoing Articles of Amendment have been prepared and executed on April 2, 2002, by the Incorporator named in the Articles of Incorporation of the Corporation before the issuance of any shares of

stock and before the organizational meeting of the Board of Directors, pursuant to Section 607.1005, Florida Statutes.
