**ARTICLES OF INCORPORATION

The undersigned incorporates, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I- NAME

The name of the corporation is Puent's Houses Corporation

ARTICLE II - PRINCIPLE OFFICE

The corporation shall engage in any activity or business permitted under the laws of the United States and if this State. Its principle office shall be located 550 East 53 street Hialeah, Florida 33010

ARTICLES III - CAPITAL STOCK

The capital stock of the corporation shall consist of a one hundred (100) Shares of 1.00 per Value. For incorporation purposes, each share will have a nominal value set at one dollar (1.00) per share as a consideration

- d. The holders of these shares of common stock are to have pre-emptive rights in the purchase of subsequent issues of stock.
- e. In the event any shareholder be unable to attend a shareholder's meeting, the shareholder may vote his share or shares by proxy, one share representing one vote.
