## **ARTICLES OF INCORPORATION**

### **OF**

C. DOUGLAS PAGE, DVM, P.A.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

### **ARTICLE I - NAME**

The name of this Corporation is: C. DOUGLAS PAGE, DVM, P.A.

### **ARTICLE II - NATURE OF BUSINESS**

The Corporation is to provide veterinary and related services to businesses and the public.

### **ARTICLE III - CAPITAL STOCK**

**ARTICLE XII - AMENDMENT**


