ARTICLES OF INCORPORATION OF JITEN J. MASTER, D.D.S., P.A.

The undersigned incorporator makes and files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional association under the laws of the State of Florida.

ARTICLE I Name

The name of this corporation shall be JITEN J. MASTER, D.D.S., P.A.

ARTICLE II Term of Existence

CZ -OS- 02

This corporation shall commence effective upon execution of these Articles and shall have perpetual existence.

ARTICLE III Principal Office/Mailing Address

The principal office and mailing address of the corporation shall be 624 E. Colonial Dr., Orlando, FL 32803 until such time as the corporation notifies the Department of State of the State of Florida of any change.

ARTICLE IV Nature of Business

The general nature of the activities of this Professional Association shall be:

- A. To engage solely and specifically in the business of rendering dental services that are customarily provided by licensed doctors of dentistry under the laws of the State of Florida.
- B. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the rendering of such professional services.
- C. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objects of this corporation enumerated in these Articles of Incorporation, or any amendment thereto, necessary or incidental to the protection and benefit of this corporation; and in general, either alone or in association with other corporations, firms or individuals, to carry on any

lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objects of this corporation.

D. To conduct those lawful activities that are authorized by Chapter 621, Florida Statutes, as from time to time amended, and to exercise those powers, rights and procedures set forth in Chapter 607, Florida Statutes, in a manner not inconsistent with Chapter 621, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

ARTICLE V Capital Structure

- A. The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 100,000 shares of common stock having a par value of \$.01 per share, which shall be without preemptive rights.
- B.
