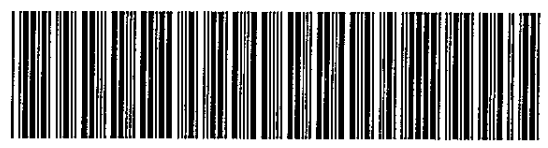



The name of the corporation to be dissolved is NR Inspection Services, Inc.


**SECOND:**

Dissolution of this corporation was approved by the Shareholders. The number of votes cast for dissolution was sufficient for approval.


