### ARTICLES OF INCORPORATION

#### $\mathbf{OE}$

#### PRESTIGE CARPET & TILE, INC.

#### **ARTICLE I**

The name of the corporation is PRESTIGE CARPET & TILE, INC.

#### ARTICLE II

The corporation shall have a perpetual existence.

#### **ARTICLE III**
