ARTICLES OF INCORPORATION OF FOCALPOINT MEDIA SOLUTIONS, INC.

Article I

Name. The name of this Corporation is Focalpoint Media Solutions, Inc.

Article II

Principal Office. The address of the principal office of the Corporation is 2701 N.W. 23rd Blvd. Suite BB182, Gainesville, FL 32605.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose.
