ARTICLE I
NAME

The name of this corporation is: LAZARO MORA IRON ARTISAN, INC., a Florida Corporation.

ARTICLE II
DURATION

This corporation shall exist on a perpetual basis commencing on the date of the signing of these Articles.

ARTICLE III
PURPOSE


