**Article I**

The maximum number of shares that this corporation is authorized to have outstanding at any one time is: Two Thousand shares at \$1.00 par value. The consideration for each share shall be fixed by the Board of Directors.

This corporation is to exist perpetually.

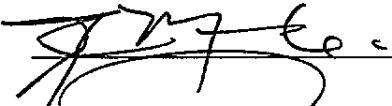
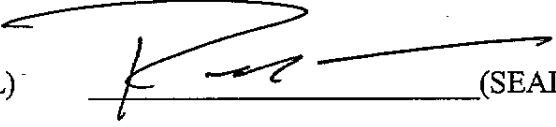

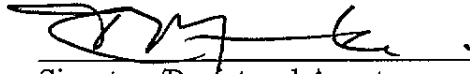
