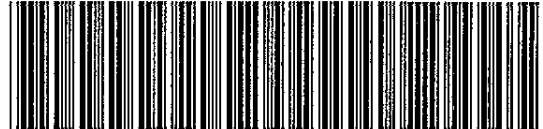

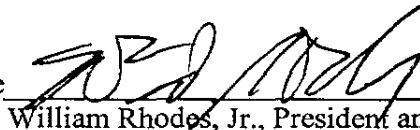
THIRD: The date of adoption for this Amendment is: April 8, 2003.
