# ARTICLES OF INCORPORATION OF Equity Homes, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Borida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## ARTICLE VIII PURPOSE


