**ARTICLE I
NAME**

The name of this corporation is **INNOVATIVE TRAINING SYSTEMS, INC.**

**ARTICLE II
DURATION**

This corporation shall have perpetual existence, commencing on the date of filing of these Articles with the Secretary of State of the State of Florida.

**ARTICLE III
PURPOSE**

This corporation is organized for the following purposes:

A. To transact any and all lawful business.

B. CAPITAL STOCK**

**ARTICLE X
OFFICERS**
