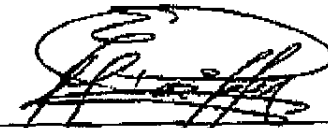

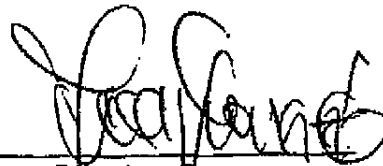
XI- AMENDMENT
