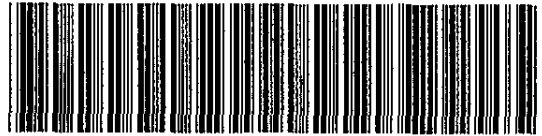

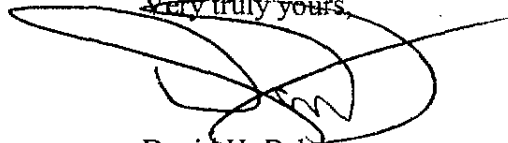

- FOURTH: The directors and the sole shareholder of J.W. CHEATHAM, INC. have no intention of revoking the dissolution.

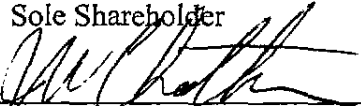
