# ARTICLES OF INCORPORATION OF AES RESEARCH, INC.

#### **ARTICLE I - NAME**

The name of this corporation shall be AES Research, Inc.



#### **ARTICLE II - PURPOSE**

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

## **ARTICLE III - CAPITAL STOCK**

The maximum number of shares of stock this corporation shall be authorized to have outstanding at any one time shall be **seven thousand five hundred (7,500)** shares of common stock of the par value of one dollar (\$1.00) per share, upon which there are no preemptive rights except to the extent specified by the By-Laws. # **ARTICLE V - TERM OF EXISTENCE**

This corporation will exist perpetually.

# ARTICLE VI - PRINCIPAL OFFICE
