In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

One: The name of the corporation shall be **Blue Opus, Inc.**

Two: The address of the principal office shall be:

Three: The purpose of this corporation is to engage in any lawful activity for which a corporation may be organized under the General Corporation Law of Florida other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Corporation Code.

Four: This Corporation is authorized to issue only one class of shares of stock, which shall be designated common stock. The total number of shares it is authorized to issue is 1000 shares.

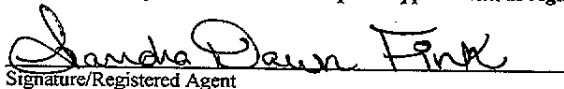
