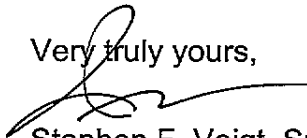

The name of this corporation is K & K SALES, INC.

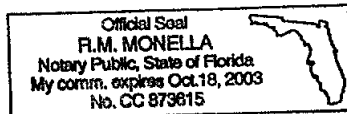
